When registration is submitted, team managers will receive an email from Team Sideline with instructions on how to roster team players.

The CRLA and Casper Recreation Center reserves all rights to make any rule/ disciplinary determination upon any rule not covered below; this includes but does not limit us to defaulting to the National Federation of State High School Associations or alternate City League Rulebook in which precedent has been set for a rule determination.

#### GENERAL INFORMATION:

- 1. All league information will come from the Recreation Division located in the Casper Recreation Center, 1801 E 4th, 235-8383. All team fees should be directed to this address during normal business hours or paid online at <a href="https://www.activecasper.com">www.activecasper.com</a>.
- 2. Team Fee: \$300.00 per team. (Minimum 4 players/maximum 12 players.) Checks must be made payable to the <u>City of Casper</u> or <u>Casper Recreation Center</u>.
- 3. Team Rosters: All Roster/Liability Release Forms will be completed online at www.teamsideline.com/casperwy. Team managers will need names and email addresses from players to successfully add to team rosters. Once the team manager adds a player with email to their roster, the player will receive an email to enroll on the team. Players will also complete the liability release form during enrollment online. It is the team manager's responsibility to ensure their players are rostered. Individuals must have personal email addresses in order to enroll on the team after receiving an email from their captain. Individuals are not permitted to use the same email (i.e. married couples, parents/children) because the software won't allow duplicate emails to enroll.
- 4. <u>Player Eligibility:</u> Players must be 15 years of age or older in order to participate. Individuals who are playing or have played collegiate (does not include red shirts), high school or professional volleyball during the 2025 season are not eligible for league play.
- 5. Teams MUST have a roster upon their first regular season game and may make additions to their rosters until the last Friday of the regular season. The last Friday of the regular season is the roster deadline. Teams will not be permitted to make additions after this point as they will be locked. At any point, a team must have the minimum number of players on their roster that is required for a team to participate in the league (i.e.: A basketball team must have 4 players on their roster). Throughout any point of the season, a team (and only the team scheduled to play them that night) may call for a roster check of their opponent. In this instance, the check must be requested and completed before the beginning of the game. If any dispute of an illegal player comes after the beginning of the game, it will NOT be investigated and the game will proceed. When a roster check is requested, staff will conduct the roster check utilizing the public end of the Teamsideline website portal. If a player not rostered on a team is found before the game begins, the player will be asked to leave. In certain circumstances, a team may be allowed a drop or addition due to injury or alternate reason. These additions and drops are left at the discretion of the Recreation Department.
- 6. Players may only play on and be rostered on one team.\*The definition of an illegal player is a player who is not on the roster of the team on the court or is on a roster for a different team.
- 7. Schedules will be posted at www.teamsideline.com/casperwy.

8. Tentative schedule is as follows: (Dates: August 25 – November 29)

Women's Leagues: Monday, Tuesday, Wednesday, Thursday
Men's Leagues: Wednesday (if needed) and Thursday

This schedule may change. Games will tentatively begin at 5:50 pm.

#### LEAGUE PLAYING RULES

National Federation of State High School Association Volleyball Rules for 2025 shall govern play, insofar as they do not conflict with the rules stated herein:

- 1. Prior to the start of each game, the official shall conduct a coin toss between the managers of each team. The official shall ask the winner of the toss whether their team chooses to:
  - a. Serve/Receive
  - b. Select the playing area

The loser of the toss will be given the remaining choice.

- 2. The net height shall be approximately 7'4 1/8" for women and 7'11 5/8" for men.
- 3. A game consists of two 25-rally point sets, decided by at least 2 points, with a cap of 27 points; and one 15-rally point set, decided by at least 2 points without a cap. All three sets will count toward league standings.

Tournament Scoring: A game consisting of two 25-rally point sets, decided by at least 2 points, with a cap of 27 points. If the first two sets are won by the same team, a third set won't be played, but if a third set is played it will be played to 15-rally points with no cap must win by 2.

- 4. There shall be no uniform requirement for league play; however, teams planning to play in out of town tournaments should have matching, numbered jerseys.
- 5. Substitutions may be made during any dead ball period. Teams may use a simple rotation method to get substitutes into the game (a sub enters the game at every rotation into the same floor position where the exiting player vacates) or they may utilize a straight substitution method (a player returns to the game only for the person who substituted for him/her).
- 6. Game time is forfeit time. One set will be forfeited at the scheduled game time, the second set will be forfeited at 10 minutes following scheduled game time and the game will be declared a forfeit at 20 minutes past game time. A forfeit fee of \$50.00 will be assessed any team which forfeits a complete game for any reason without notification to the Casper Recreation Center Supervisor by 12:00 noon the day of the event. This fee must be paid <u>before</u> that team's next scheduled game or the team will not be eligible for the season ending tournament.

- 7. A team shall be comprised of 6 players all of the same gender. Men may only play in the men's league and women may play only in the women's league. A team may play with as few as 4 players.
- 8. If a player arrives late and a team is playing with less than 6 players, that player may enter the game on the first dead ball at any position on the court. If a team has 6 players present and an additional player arrives, that player may enter the current game following applicable rotation and substitution rules.
- 9. Any ball hitting an overhead obstruction (backboard, ceiling and support beams) shall remain in play providing the ball remains on your side of the net, your team has a hit remaining and it does not occur on the serve. A ball which travels through the rafters or above the suspended basketball baskets is considered in play unless it makes contact with such object(s) as described above.
- 10. The dividing net between courts #1 and #2 and courts #2 and #3 is out of bounds and will be declared dead if the ball touches it. Due to safety reasons, players are NOT ALLOWED to push the dividing net so another player can hit the ball. If this happens, the ball will be declared dead, resulting in a sideout.
- 11. A player is allowed to have his or her foot on the center line below the net. However, once the entire foot crosses the line into the opposing team's court, the result is an under-the-net violation with either a sideout or a point for the opposing team.
- 12. Blocking a served ball is not permitted. A ball may be attacked, excluding a served ball, when it has partially crossed the net. Attacking (spike, tip, dump, overhand pass) a served ball while the ball is completely above the height of the net is not permitted.
- 13. **ONLY** team captains may discuss rule interpretations with the officials.
- 14. Teams are allowed one time out per set 60 seconds in length.
- 15. A player shall receive one service tossing error per rotation. Players are **NOT ALLOWED** to jump overhand serve in Women's Division 9 or 10.
- 16. Profanity and unsportsmanlike conduct can result in ejection and/or disqualification from future games (See Code of Conduct).
- 17. Players are allowed to wear jewelry/watches.
- 18. The ball furnished by the Casper Recreation Division shall be the official game ball.

#### LEAGUE STRUCTURE AND TOURNAMENT PROCEDURE

Teams are placed into divisions based as much as possible by their own choice; however, the CRLA Board will make the final decisions on division alignment. Regular season schedules will consist of round robin play. All teams will qualify for the double elimination tournament at the end of the season. For tournament play, teams will be divided into divisions to make the tournament as competitive as possible. Plaques will be awarded based on the number of teams in each division for regular season, as well as, the post season tournament.

The following is the policy for determining league champions:

- a) Outright league champions (best winning percentage).
- b) Head to Head
- c) Head to Head Differential
- d) Total Point Differential
- e) Coin Toss

#### CASPER RECREATION CENTER RULES

When playing in the Casper Recreation Center, every participant will be required to follow the rules listed below:

The gym shoes worn on the gym floor cannot be the same shoes worn in from the outside. Shoes must be changed before participating in the gym. The gym shoes must be non-marking.

Participants who desire to use the locker rooms are required to have a Casper Recreation Center Annual Pass or pay a daily admission fee. This pass is to be turned in at the reception counter upon entering the facility and should be picked up when leaving.

Children 14 years or younger will be allowed in the gymnasium area to watch games providing they are sitting with a *non-playing adult*. Non-supervised children will not be allowed in the gymnasium area and will be asked to leave. Anyone bringing unsupervised children to the gym will be asked to remedy the situation or risk forfeiture of their team's game.

The City of Casper <u>DOES NOT</u> carry insurance for participants in any City sponsored teams. Team and individual insurance may be obtained from various companies. For more information, contact the City of Casper Risk Manager's Office at 235-8212.

### **Code of Conduct**

The Casper Recreational Leagues Association (CRLA) wants to ensure that games are fair, positive and enjoyable experiences for all that are involved. The CRLA expects all athletes, coaches/managers, officials/umpires and spectators to hold themselves to high standards of sportsmanship. Officials/Umpires and game management are there to help ensure fair play and provide a positive experience for everyone. Please treat all accordingly. In keeping with our mission, the CRLA expects all players, coaches, referees/umpires and spectators to maintain self-control at all times while remaining positive and showing respect for your team, opponents and officials/umpires at all times.

As a participant in CRLA Leagues, it is your responsibility to uphold and enforce the Code of Conduct including the following:

- 1) No player, official, spectator or participant shall at any time lay a hand upon, shove, strike, spit on or at or threaten another player, official, spectator or participant. Officials/Umpires are required to suspend the player(s) immediately from further play and report such player(s) to the Recreation Supervisor of Sports. Such player(s) must leave the facility immediately and shall remain suspended until the CRLA Board Representatives and Recreation Supervisor of Sports have considered their case.
- 2) No player(s) shall at any time refuse to abide by an official's decision, use obscene gestures or language, be guilty of an abusive verbal attack upon any player, official or spectator, or use unnecessary tactics including those against the body or person of an opposing player. The "F" word will result in an automatic ejection. Officials/Umpires are required to suspend such player(s), who must leave the facility, immediately from further play and report such player(s) to the recreation Supervisor of Sports. If during tournament play, the player(s) is not eligible to compete in the balance of the tournament. If, for any reason, the player is not ejected, Casper Recreation Staff reserves the right to enact any and all disciplinary action.
- 3) Teams MUST have a roster upon their first regular season game and may make additions to their rosters until the last Friday of the regular season. The last Friday of the regular season is the roster deadline. Teams will not be permitted to make additions after this point as they will be locked. At any point, a team must have the minimum number of players on their roster that is required for a team to participate in the league (i.e.: A basketball team must have 4 players on their roster). Throughout any point of the season, a team (and only the team (s) scheduled to play them that night) may call for a roster check of their opponent. In this instance, the check must be requested and completed before the beginning of the game. In certain circumstances, a team may be allowed a drop or addition due to injury or alternate reason. These additions and drops are left at the discretion of the Recreation Department.
- 4) An ejected player is ineligible for all CRLA sanctioned play for two games and he/she must pay the City a \$50.00 fine prior to playing again. The \$50.00 fine must be paid by 12:00 pm (noon) of the date the ejected player is eligible to rejoin the league. The \$50.00 fine and suspension will carry over to the next applicable season if it has not been paid.
- 5) No player(s) shall possess alcohol, drugs or be under the influence of such. Softball: No player(s) shall smoke tobacco products on the field of play (within the fences or dugout). Officials/Umpires are required to suspend such a player(s) (in case of smoking at Softball Fields only after a verbal warning) immediately from further play and report player(s) to the Recreation Supervisor of Sports.

Penalties for the above infractions will be:

MINIMUM PENALTY: Suspension for two league games, probation for the remainder of the season.

MAXIMUM PENALTY: Suspension from all CRLA sponsored events for two years and probation for the following year at the discretion of the CRLA Board of Directors and Recreation Supervisor of Sports. Suspension from all Recreation Division Sponsored facilities and programs for two

#### ATHLETIC LEAGUE REFUND POLICY

#### TEAM ENTRY FEES

Planning for athletic leagues is extensive. Not only do the facilities have to be secured for a defined length of time, but divisions have to be drawn up and the length of the season (number of games, etc.) has to be determined before the actual game scheduling begins.

Much of this is done on projection based on the number of teams from the previous year. However, the final organization and scheduling (which is the most time consuming) does not begin until the deadline for submitting team fees has passed.

If a team drops out at this point, it will affect the division draws that have already taken place. To have to re-draw divisions or to back up and have to reschedule a division is costly and time consuming.

Teams should be certain that they would have enough players before they pay their team fee. When they pay their team fee, they are making a commitment to field a team and should be held responsible for upholding that agreement.
