## FACILITY RENTAL GUIDELINES

Thank you for choosing to rent the Placerville Aquatics Center! Listed below are a few details that we would like you to be aware of before your rental. If you have any questions regarding your rental, please contact the Recreation Department at (530) 642-5232. For the safety of all our guests, all facility rules remain in effect during pool rentals. We hope you enjoy your time at the pool!

1. The Facility rental is for the 2-hour time specified in your Facility rental application. In some cases, it may be possible for renters to arrive early to “set-up” their party, but this is not guaranteed and advance approval is required. If the renter is interested in an early arrival for set-up purposes only, please contact the Recreation Department at least 3 business days in advance to request approval for early arrival.
2. Rental groups are responsible for cleaning the area used for the rental, using trash receptacles provided. This includes all trash, decorations, and any large spills that may have occurred. Failure to do so will result in forfeiture of the cleaning and damage deposit.
3. All participants must exit the water at the conclusion of the 2-hour rental period. Facilities must be vacated within 10 minutes of the conclusion of the rental period. **Failure to do so will result in forfeiture of the cleaning and damage deposit.**
4. Chaperones must be provided for all participants under the age of 12 in a ratio of one chaperone for every five children. Chaperones must be responsible individuals ages 16 and older.
5. If the facility is damaged by a person or persons in your group, the total cost of repairs will be the responsibility of the renter.
6. Full payment and a \$50 cleaning and damage deposit is due at the time of making the rental application. Refunds are available if canceling on our before 12 noon, the Wednesday before your rental. **No refunds** will be granted after this deadline.
7. Parking availability is not guaranteed and may be limited due to other events. The use of St. Patrick Church’s parking lots (the lots directly across from the pool) is not permitted during rentals held on Saturdays.
8. At least one shade structure will be reserved for each pool rental.
9. Decorations are permitted in the shade structure area only. No latex balloons or confetti, please! If tape is used, only white masking tape or blue painters’ tape is permitted. Renter is required to remove all decorations at the end of the rental time.
10. Pool rentals may not exceed 150 people (including spectators) without additional conditions and guidelines as determined by Recreation staff.
11. Rental groups shall be permitted to use the portion of the facility on the days and times identified in their agreement only.
12. Rental groups shall use the main facility entrance unless otherwise instructed.
13. Lifeguards are provided by the City based upon the size and type of rental requested. Agreed-upon attendance levels are indicated on your application. Any increase in attendance will result in an increase in fees and a possible delay in facility use as additional staff will be needed.
14. All guest behavior is subject to management staff approval. Please be sure to review the pool rules with your guests before swimming. A manager can assist you if desired.
15. Rafts and other floatation devices, including water wings and swimsuits with floatation sewn-in are not permitted in the pool. Coast Guard approved life jackets are permitted.
16. Guests must be 48 inches tall to ride the waterslide. Only one person is permitted on the slide at a time. And weights less than 300 lbs.
17. Food must be eaten in designated areas along the seat wall and under the shade structures during pool rentals. No barbecues or open flames are permitted.
18. Proper swim attire is required to swim at the Aquatic Center and follow the facility dress code.
19. Applications may take 7-10 business days for approval. Approval is based on staffing needs for the rental.

## **RULES**

### **FACILITY RULES**

- All people entering during public swimming must pay an entrance fee.
- Children under 12 years of age must be accompanied, and closely supervised, by a responsible person 16 years or older.
- Coast Guard approved Type II and Type III lifejackets are permitted. No other flotation devices or swimming aids are allowed.
- Non-swimmers and those in life jackets must always be with an adult and are required to stay in shallow water.
- Diving is allowed only in designated areas of the deep end.
- Running and rough play are not allowed.
- Swimming attire must be clean and appropriate for our family-oriented facility.
- Children who are not trained in bathrooms must wear a swim diaper.
- Food is allowed in seating areas, away from the edge of the pool.
- Loitering in showers or bathroom areas is not permitted.
- The following are not allowed in the pool area: alcohol, tobacco products, smoking, e-cigarettes, weapons, glass containers, bikes, skateboards, scooters, and gum.
- Animals are not allowed on the pool deck, except for service animals.
- Spitting and nose blowing in the water is prohibited.
- Admission will be refused to any person with skin lesions, infections, or contagious disease.
- Valuables should not be left unattended. The Placerville Recreation Department is not responsible for lost or stolen property.
- All patron behavior is subject to manager approval.

### **DIVING BOARD RULES**

- Only swimmers who are confident in deep water, and able to swim the width of the pool, are permitted to use the diving board.
- Swimmers must remove lifejackets when using the diving board.
- One person is permitted on the board at a time.
- No running on the diving board.
- Only one bounce on the end of the board is permitted.
- Divers must jump or dive straight off the end of the diving board.
- Only forward jumps, dives, and flips are permitted.
- After entering the water, divers must swim directly to the nearest ladder or under the rope.
- When the diving board is open, swimming in the deep end is not permitted.
- Lifeguards, at their discretion, may stop any diving activity deemed unsafe.

## **RULES (CONT.)**

### **SLIDE RULES**

- The operational limit for the slide is one person, 300 pounds.
- Participants must be at least 48 inches tall to ride the slide.
- Walk on stairs and use handrails.
- Wait for permission from the slide dispatcher before entering slide, then enter from a sitting position.
- Slide feet-first, lying down with legs straight in front and arms crossed over chest.
- Arms and hands must always remain inside the flume.
- Goggles and swimwear with zippers, rivets, or metal are not permitted.
- Stopping on the slide and climbing up the slide is not permitted.
- After entering the water, quickly exit the slide area and follow the lifeguard's directions.
- Pregnant women and persons with heart conditions or back trouble should not ride.

### **ACTIVITY POOL RULES**

- Children must be accompanied, and closely supervised, by a responsible adult.
- Children ages 2 and younger must always remain within arm's reach of their attendant,
- No one over the age of 8 is permitted in the activity pool.
- Participants are encouraged to turn valves, pull ropes, and interact with the play structure.
- Hanging and swinging on pull ropes is not permitted.
- Climbing on pipes, handrails, or the outside of the play structure is not permitted.
- No running, jumping or diving permitted.
- Only one person on the slide at a time.
- Participants must slide feet first, on back, and immediately leave the landing area upon exiting.
- Children who are not trained in bathrooms must wear a swim diaper. Poolside diaper changing is not permitted.
- Food is allowed along the seat wall only.
